Note:

- 1) The Election result will be subject to decision of appeal (if any).
- 2) If any person submits nomination forms for different posts, and except one does not withdraw rest of the nomination forms, within specified date shall be disqualified to participate in the elections. His name shall not be printed upon ballot papers.
- 3) If the candidate appears to be un-opposed on the day of decision of objection(s) or on the last day of withdrawal, meaning thereby, polling is not required, then the notification may be issued immediately.
- 4) Polling will be started on time and will be closed as and when the voters present in hall would have cast their votes.
- 5) **Mobile phones are not allowed in the polling hall.**
- 6) Ballot papers shall be cancelled, in case the ballot paper shown to any person, double stamped, any marking on ballot paper etc.
