

Ehsan Mani

Ehsan is a Fellow of the Institute of Chartered Accountants (England & Wales) having qualified in 1970.

He is a past Chairman & President of the International Cricket Council 2003-06. He chaired the ICC Finance Committee (1996-2002) and led in the commercialisation of ICC Events by raising over \$2bn from the sale of the ICC media and sponsorship rights between 2000-2007. He represented PCB at the ICC between 1989 and 1996.

It was during his tenure that ICC moved its head office from London to the UAE; women's cricket was integrated with the men's game; ICC entered into a partnership with the United Nations to promote awareness of AIDs and HIV through cricket; China was made a member of the ICC; following the Asian Tsunami and the 2005 earthquake in Pakistan, ICC raised over \$17 million for emergency relief work; the ICC Global Cricket Academy was set up in Dubai.

He was a member of PILCOM, the organizing committee for the 1996 World Cup held in Pakistan, India and Sri Lanka.

Over the years Ehsan has assisted Pakistan and West Indies cricket boards in the sale of their media rights raising hundreds of millions for the game in these countries.

He was, until September 2015, the Senior Independent director of one of the largest affordable housing companies in the UK (assets in excess of GBP4billion), where he was also the Chair of the Audit & Risk Committee and a member of the Strategic Finance Committee.

He served as a director of two banks in the United Kingdom for over 25 years; chairing the Audit & Risk Committees of both the banks. He has also served on the Prime Minister of Pakistan's Inspection Commission as a co-opted member in 1990-1992 to review and report on WAPDA and PIA.

He is on the Board of Governors of Shaukat Khanum Memorial Trust, where he also chairs the Audit & Finance Committee. He is the Chairman of the Finance

Committee of Lady Reading Hospital Peshawar and is a trustee of a number of other charities in Pakistan and the United Kingdom; including The Sir Feroze Khan and Lady Viqar-un-Nisa Noon Foundation set up to provide financial assistance to Pakistani students admitted to Oxford and Cambridge universities. He is a Trustee of the Sanjan Nagar Educational Trust in Lahore which provides high quality education to under privileged children.

He is the chairman of the Galiyat Development Authority which oversees the administration of the Galiyat area in KP. He chairs Ansar Management Company Limited, a joint venture between Places for People Group UK, Reall (formerly Homeless International UK) and Ansar Management Company set up to build affordable housing in Pakistan. The overseas investors will invest approximately \$30-50m over the next 5 years and plan to build over 5,000 homes.

Ehsan Mani has been involved in environment protection and reforestation projects in the Galiyat area of Hazara Division for over 20 years including planting of over 1.5 million trees.
