Subject: Election of Regional Cricket Association (RCA) Sialkot

In continuation of this office letter dated 24th September 2018.

Due to the outcome of W.P No. 235625/2018 titled Imran Rafique Vs Pakistan Cricket Board etc decided on 5th October 2018 by the Honorable Lahore High Court names of voters from Narowal have been finalized.

Under paragraph 2 of Election Regulations (approved by PCB Board of Governors on 13th June 2015), 2/3rd of the electoral college is available to cast vote.

Now a fresh election schedule is being issued. Those candidates, who have submitted nomination forms to PCB, are not required to submit their forms again.

The election for the seats of President & Secretary RCA Sialkot will be held **as per attached schedule**.

The interested/desirous candidates are required to submit the duly filled nomination forms along with demand draft amounting to Rs. 15,000/-each in favour of Pakistan Cricket Board by **29th November 2018 positively**.

Kindly inform all voters and circulate the above documents to all concerned. Please also inform the local press.



- 1) The Election result will be subject to decision of appeal (if any).
 - 2) If any person submits nomination forms for different posts, and except one does not withdraw rest of the nomination forms, within specified date shall be disqualified to participate in the elections. His name shall not be printed upon ballot papers.
 - 3) If the candidate appears to be un-opposed on the day of decision of objection(s) or on the last day of withdrawal, meaning thereby, polling is not required, then the notification may be issued immediately.
 - 4) Polling will be started on time and will be closed as and when the voters present in hall would have cast their votes.
 - 5) **Mobile phones are not allowed in the polling hall.**
 - 6) Ballot papers shall be cancelled, in case ballot paper shown to any person, double stamped, any marking on ballot paper etc.
