Subject: <u>Election of Regional Cricket Association (RCA) Peshawar</u>

In continuation of this office letter dated 5th September 2018, whereby, the election schedule of RCA Peshawar was suspended in pursuance of the learned civil court order dated 1st September 2018. Now the case has been dismissed as withdrawn.

The election schedule of RCA Peshawar was issued on 24th August 2018 and nomination forms of candidates had been received by due date i.e. 31st August 2018. The nomination papers of Mr. Akhtar Ali and Sar Draz Khan were received for the seat of President but they had withdrawn their candidatures, therefore, Mr. Hussain Ali is notified as un-opposed President of RCA Peshawar.

Now the election process for the seat of Secretary will continue from a point where it had been stopped upon court order. Therefore schedule of remaining process is being issued <u>along with list of voters and candidates.</u>

- 3) If the candidate appears to be un-opposed on the day of decision of objection(s) or on the last day of withdrawal, meaning thereby, polling is not required, then the notification may be issued immediately.
- 4) Polling will be started on time and will be closed as and when the voters present in hall would have cast their votes.
- 5) Mobile phones are not allowed in the polling hall.
- 6) Ballot papers shall be cancelled, in case ballot paper shown to any person, double stamped, any marking on ballot paper etc.

The objections filed against above candidates do not fall under the relevant clause so the same are dismissed.
