## Asia Cup 2023 Match Tickets

## **Terms & Conditions**

These Terms and Conditions ("Terms") govern the sale and use of tickets for matches being played as part of the 2023 edition of the Asia Cup organised by the Asian Cricket Council (ACC) and hosted by the Pakistan Cricket Board (PCB) with the support of Sri Lanka Cricket (SLC) (the "Match"). Purchase or use of this constitutes acceptance of the terms and conditions set out hereunder.

- Tickets are non-transferable and non-refundable, except as expressly provided in these Terms
  or required by law. Only tickets purchased from PCB authorised outlets are valid for entry.
  PCB and SLC reserve the right to cancel Tickets if obtained fraudulently or in violation of these
  Terms.
- 2. The ACC and PCB reserve the right to change the Match date, time, or venue, or to cancel the Match, due to unforeseen circumstances. In such cases, the ACC/PCB will provide information regarding rescheduling, refunds, or ticket exchanges as applicable. Refunds will only be issued in accordance with applicable laws and the PCB's refund policy.
- 3. While the right of admission is reserved at the discretion of the PCB and SLC, holders of the ticket are entitled to enter the stadium and to view the match from the seat or area to which this ticket refers.
- 4. The PCB and SLC will make reasonable efforts to provide the seating area specified on the Ticket, but reserve the right to change seating assignments if necessary. PCB and SLC do not guarantee that the ticket holder will have an uninterrupted and or uninhibited view of the match from the seat provided NOR does the PCB or SLC Management make any guarantee as to the quality of the Match.
- 5. This ticket must be kept in good condition and presented upon request for entry to the Match venue at appropriate entry points and/or on demand by any authorized official. Holders of Tickets may be subject to security checks and bag searches at the Match venue.
- 6. Unauthorized photography, filming, recording, or broadcast of the Match is strictly prohibited,
- 7. Ticket holders must comply with all venue rules and regulations, including those related to behavior, prohibited items, and safety instructions. The ticket holder will be prohibited entry if under the influence of alcohol or in possession of Restricted Items such as, inter alia, glass objects, alcoholic beverages, visual recording equipment (Video cameras, lap-top, computers and professionals). It is strictly forbidden to bring Restricted items to the venue.
- 8. The playing field shall be out of bounds at all times on the day of the match to the ticket holder.
- 9. The ticket holder shall not behave in any manner deemed by the PCB or SLC Management to be disruptive, to endanger the safety of other persons in the Stadium or to the unreasonably obstruct the viewing of other spectators. Disorderly conduct or failure to comply with venue rules may result in expulsion from the Match venue without refund.
- 10. The use of tickets as prizes in lotteries or competitions is strictly prohibited.

- 11. Any ticket obtained in breach of these conditions shall be void and all rights connected there which shall be nullified. Any person seeking to use a ticket obtain in breach of these conditions will be refused or evicted from the stadium or demarcated areas and no refund will be made.
- 12. Should the ticket holder leave the stadium and/or demarcated areas and wish to re-enter the Stadium and/or demarcated areas, this ticket must be produced at the appropriate entry points.
- 13. The PCB, SLC and/or ACC will not be liable for any loss, injury, damage, or theft of personal belongings incurred at the Match venue. Ticket holders attend the Match at their own risk and release the PCB and ACC from any liability for personal injury or property damage. Ticket holders agree to indemnify and hold the PCB, SLC and ACC and its authorised representatives harmless from any claims, demands, or liabilities arising out of their attendance at the Match.
- 14. Failure to observe and abide by these terms and conditions shall constitute breach of contract and may result in eviction from the stadium and demarcated areas, cancellation or confiscation of this ticket and/or legal action by the Management.
- 15. The ticket holder shall not conduct or cause to engage on any form of betting or gambling within the Venue, if so detected, will be evacuated from the stadium and may be subject to criminal prosecution.
- 16. Spectators are reminded that racially abusive comments and actions will result in ejection from the ground.
- 17. Children of 3 years of age or over must have their own ticket.
- 18. The PCB reserves the right to modify or update these Terms without prior notice. Any changes to these Terms will be posted on the PCB's official website.
